SUBJECT: VERIFICATION CHARGES

By the Order of Hon'ble Vice Chancellor, this is notified that as per the provisions of **Sub Section-8(xxv)** of the **YBN University Act 15, 2017**, the authorities of YBN University, Ranchi (Jharkhand) have implemented the **Verification Charges** for checking the authenticity of the Educational Documents/Certificates/Degrees/Official Transcripts/Marks Sheets/Experience Certificates and other Official Documents which have earlier (during past period) been issued by the competent Authorities/concerned Authorities of YBN University, Ranchi (Jharkhand) in favour of its Students as well as its Employees. These **Verification Charges** shall be specifically applicable to all the Third Parties/Private Companies/Private Institutions/Private Universities/Private Organizations/Private Verification Agencies. All the Agencies of the Central/State/UTs Government & Semi-Govt./Central & State Govt. Institutions/Central & State Govt. Authorities/Public Bodies & Public Authorities/Foreign Embassies/Indian High Commissions or Embassies throughout the Globe shall be **exempted** from any **Verification Charges** for checking the Authenticity of the above mentioned Documents etc. The below mentioned **Verification Charges** shall be applicable **w.e.f.** 16th September, 2023 onwards till further Notification in this context for the Documents etc. received per Set/Single Document at a Time from any Source.
