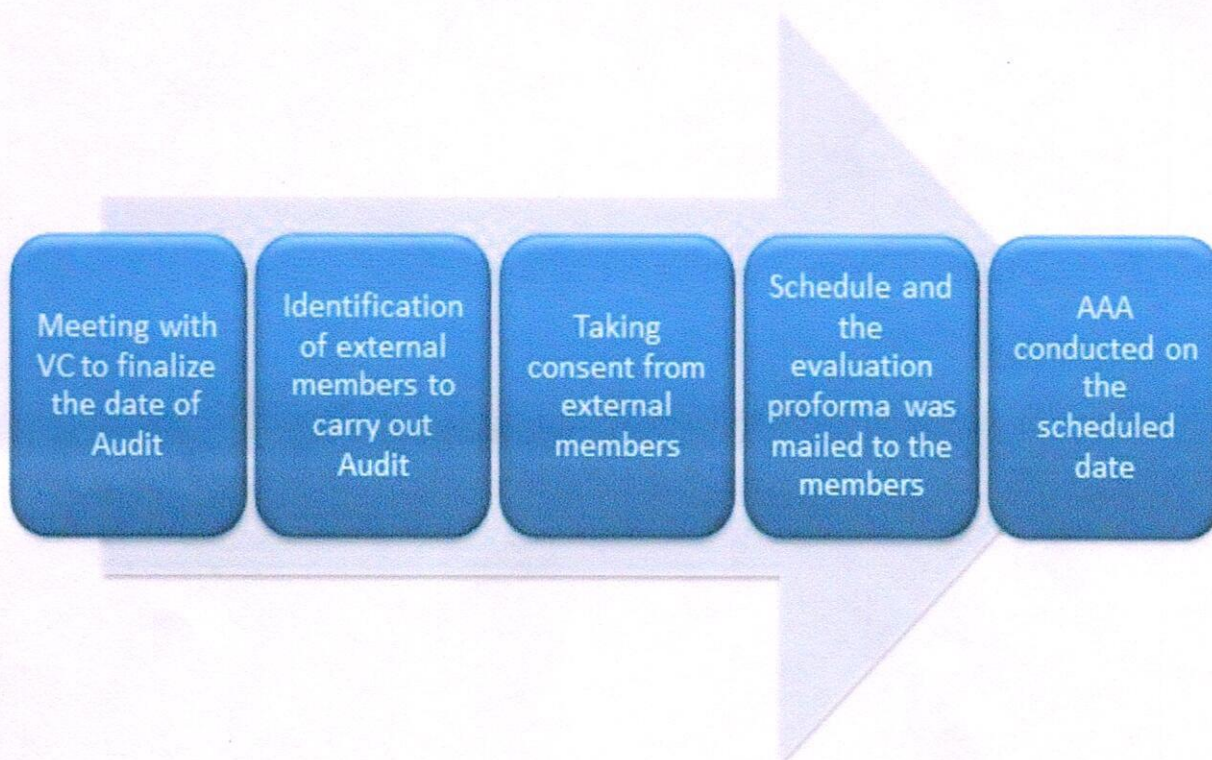



1 Establishment of more and
strengthened sophisticated
laboratories

The University has initiated the process to augment its laboratory facilities by adding new equipment and strengthening the existing ones. The proposal includes setting up an advanced instrumentation laboratory for pharmacy and biotechnology, with state-of-the-art equipment. Approval for funding and procurement is underway.

2 More books related to Legal
Studies and Computer Science

The University has placed a requisition for additional books and journals related to Legal Studies and Computer Science. The library team is currently finalizing the list of titles and journals to be purchased in consultation with respective department heads and subject experts.

3 More journals

The University has subscribed to additional journals and databases to aid both the faculty's and the students' academic and research endeavors. This includes national and international journals related to pharmacy, legal studies, and computer science.

4 Water sprinkler and solar
panel

The University is currently in the process of installing a water sprinkler irrigation system to aid in conserving water and maintaining green spaces on the campus. Additionally, steps are underway to install solar panels to enable the institution to become more energy efficient and reduce its carbon footprint.
