REGULATIONS FOR OPERATIONALIZING ACADEMIC BANK OF CREDITS

[Based on National Education Policy 2020]

**Approved by the 19TH Academic council meeting of YBNU to be held on
(24th April 2023)**

Academic Bank of Credits is essentially a credit-based, and highly flexible, student-centric facility. Academic Bank Account with Academic Bank of Credits (ABC) will store the credits earned by students. YBN University Ranchi has been registered with the Academic Bank of Credit to recognise, accumulate, transfer and redeem the credits earned by each of the students admitted in various programmes/courses offered by the University and colleges affiliated to the university.

I. Role of the University/Colleges

1. The Controller of Examination (CoE) of YBN University shall be the nodal officer and s/he will be responsible for storing, verifying, and transfer of credits earned by the students admitted to the various programmes/courses of the academic departments/centers and colleges affiliated to YBN University.
2. The Deans/Principals in each Schools/Colleges affiliated shall function as the Nodal Officer and shall be responsible for transmitting the credits earned by the students admitted to the various programmes/courses of the Schools/college to the office of CoE, YBN University.
3. The CoE office will make provisions to accept, record and deposit the credits in Academic Bank of Credits earned by the students of YBN University, affiliated colleges, and other recognized Higher Education Institutes (HEIs) at a compatible level of education.
4. The CoE office shall make provisions to accept, record and deposit the credits earned by the students of YBN University in other recognised HEIs at a compatible level of education in the country.
5. The CoE office shall reckon the total credits earned by each of the students admitted to course considering the desired requirements in the specific course(s).
6. The CoE office shall reckon the total credits earned by each student admitted to course considering the desired requirements in the specific course(s).
7. Upon collecting a certificate, diploma or degree, all the credits earned by the students till then, in respect of certificate, diploma or degree levels of studies, shall stand debited.
8. The CoE office shall allow for credit redemption through the process of commuting the accrued credits in the Academic Bank Account maintained in the ABC for the purpose of fulfilling the credit requirements for the award of

Certificate/Diploma/ Degree (UG & PG) courses offered by academic departments/ centers and Schools/ colleges of YBN University.

II. Role of students

1. Students must inform the CoE's office through the Head of the Department, the courses adopted by them for a particular programme and semester.
2. The validity of credits earned by the students in various courses [e.g., Certificate/Diploma/Degree (UG & PG)] and kept in the Academic Credit Account will be to a maximum period of seven years or as specified by the ABC for different disciplines or fields of learning to allow the redemption of credits after the date of earning such credits. After seven years, re-entry into a programme of study will be based on the validation of prior learning outcomes.
3. Once used, or redeemed, Credits earned by a student cannot be re-used for the award of any other formal academic qualifications.
4. Students availing flexibility under the facility of ABC provided in sub- regulation (3) are entitled to subscribe only to Courses of their choice and aptitude, so as to enable them to accumulate credits and not to the entire Programme of study leading to the award of a degree by the Registered Higher Education Institution.
5. Credits earned by students shall be deposited in the respective Academic Bank Account with ABC and shall be valid for not exceeding seven years as specified by the credit awarding institutions and subject to its acceptance by the Registered Higher Education Institution awarding academic qualifications, for the purpose of commutation of credits for the award of any Degree or Diploma or Certificate: Provided that once any credit is redeemed for the award of the aforementioned academic qualification, such credit shall be irrevocably debited from the respective student's Academic Bank Account.
6. Where a student fulfils the norms of sufficiency of total number of credits and of the nature of credits, approved by a Registered Higher Education Institution for the award of the specified Degree or Diploma or Post Graduate Diploma or Certificate, the student shall be eligible for such award by that Higher Education Institution.

III. Grievance Redressal Mechanism

There shall be an Academic Bank of Credits-Grievance Redressal Mechanism at the University and in affiliated colleges to address the grievance/appeals of students.

IV. Removal of Difficulties

Notwithstanding anything contained above, the Vice-Chancellor shall have the power to remove any difficulty faced in the implementation of the above regulation.

Regulations for
Multiple Entry and Exit in Academic Programs
(MEES)

1. Preamble

To bring major reforms in the Higher Education System, National Education Policy (NEP) 2020 has provided a system of multiple entry and exit in academic programs. In this system the students shall be free to choose their programs and academic pathways in Higher Education that will support the Academic Bank of Credit (ABC). Multiple Entry and Exit System (MEES) are the fundamental recommendations of University Grants Commission (UGC), to encourage flexible learning in Higher Education Institutions (HEIs) which is important for life- long learning of the students and to choose their academic path leading to the award of certificate, diploma and degree. Under this system there will not be drop out of students. These guidelines of Entry and Exit system will tend to reduce the dropout rates with considerable improvement of Gross Enrolment Ratio (GER) to ensure no-loss to students in the case of exiting in between.

2. Concept of Multiple Entry/ Exit System

MEES shall allow the students to be their own decision makers and shall motivate them to resume learning from the point they left in between and help them to achieve their career goals in life. According to NEP regulations, undergraduate degree should be either of three or four year duration with multiple Entry as well as Exit points. One will be able to earn a certificate, diploma or degree upon completing the requirements thereof.

Certificate, Diploma or Degree are organized in levels ranging from Level 5 to Level 10 where:

Level 5 is the Undergraduate Certificate level and is for those students, who exit studies after the First year of graduation;

Level 6 is the Undergraduate Diploma level and is for those students, who exit studies after Two years of graduation;

Level 7 is the Bachelor's Degree of Three years;

Level 8 is the Bachelor's Degree (Honours/Research) of Four years;

Level 9 is the Master's Degree one/two years depending on three/four years' Bachelor's Degree, respectively.

Level 10 is the Doctoral Degree.



3. Academic Bank of Credits (ABC)

Academic Bank of Credit (ABC) shall support MEES to promote flexibility in curriculum ensuring mobility of learners across the universities of their choice.

The students shall also get an option to gain the credits by learning quality Massive Open Online Courses (MOOC) from UGC approved digital platforms such as Study Webs of Active Learning for Young Aspiring Minds (SWAYAM). This national-level credit account will facilitate the digital storage of earned credits from different HEIs and the certificate/diploma/degree shall be awarded in line with the accumulated credits in a specific duration at the Undergraduate and Master's levels.

After registration in the national ABC framework, Multiple Entry Exit System for smooth execution of multidisciplinary and flexible learning with impeccable credit count, credit transfer and credit acceptance from students' account shall be implemented.

4. Purpose of the Policy

- To reduce dropout rate and boost GER.
- Withdraw the fixed boundaries of diploma/degree completion period.
- Allow different discipline combinations such as to enable multiple entry exit points.
- Taking students' choice of courses in consideration for a flexible curriculum approach.
- A support system towards credit recognition, credit accumulation, credit transfers, and credit redemption to encourage flexible and lifelong learning.
- Although these policies shall boost vocational opportunities and enhance practical knowledge leading to national and global progress, the actual execution of such endeavors may bring real-life issues with them.

5. Process of MEES implementation

- Multiple entry points shall be available for students every year.
- The course structure of any programme shall include different courses semester wise, out of which the students may choose Entry or Exit.
- The students who have successfully completed Grade 12 School Leaving Certificates shall be eligible for admission to a first degree programme.
- The university shall earmark seats for lateral entrants to the Second year/Third year/Fourth year of a first-degree programme, if the student has either (a) successfully completed the First year/Second year/Third year of the same programme in any institution, (b) Already successfully completed a first degree programme and is desirous of pursuing another first degree programme in an allied subject.
- The Entry and Exit options for students, who enter the undergraduate programme, shall be as follows:



1st Year

Entry 1: The entry requirement for Level 5 is Secondary School Leaving Certificate obtained after the successful completion of Grade 12. A programme of study leading to entry into the First year of the Bachelor's degree is open to those who have met the entrance requirements as per YBNU norms.

Exit 1: A certificate will be awarded when a student Exits at the end of year 1 (Level 5). The First year of the undergraduate programme requires 40 to 52 credits during the First year of the undergraduate programme for qualifying for an undergraduate certificate.

2nd Year

Entry 2: The Entry requirement for Level 6 is a certificate obtained after completing the First year (two semesters) of the undergraduate programme. A programme of study leading to the Second year of the Bachelor's degree is open to those who have met the entrance requirements, as per GCU norms.

Exit 2: At the end of the Second year, if a student Exits, a diploma shall be awarded (Level 6). A diploma requires 80 to 104 credits from levels 5 to 6, with 40 to 52 credits at Level 6.

3rd Year

Entry 3: The Entry requirement for Level 7 is a diploma obtained after completing two years (four semesters) of the undergraduate programme. A programme of study leading to the Bachelor's degree is open to those who have met the entrance requirements as per GCU norms.

Exit 3: On successful completion of three years, the relevant degree shall be awarded (Level 7). A Bachelor's degree requires 120- 156 credits from levels 5 to 7, with 40- 52 credits at level 5, 80 to 104 credits at level 6, and 120 -156 credits at Level 7.

4th Year

Entry 4: An individual seeking admission to a Bachelor's degree (Honours/ Research) (Level 8) in a specified field of learning would normally have completed all requirements of the relevant three-year bachelor degree (Level 7).

After completing the requirements of a Three year Bachelor's degree, candidates who meet a minimum CGPA of 7.5 shall be allowed to continue studies in the fourth year of the undergraduate programme to pursue and complete the Bachelor's degree with Research.

Exit 4: On the successful completion of the Fourth year, a student shall be awarded a degree (Honours/ Research). A Bachelor's degree (Honours/ Research) requires a total of minimum 160 credits from levels 5 to 8.

AGENDA No. 03	To consider the Introduction of Entrance Test for admission to various PG courses

Discussion	The AC noted that the Academic Brach of the University is in receipt of applications from few Schools: 1) Science, 2) Commerce & Management and 3) Arts & Humanity for introducing Entrance test for admission to the PG courses. The collective argument put forwarded by the concern schools is that the present system of taking admission is not scientific, to test and examine the quantum of knowledge and quality of students. The observations made by these departments indicate that those students who are admitted on the basis of their high percentage are seldom found to be able to complete the course as well as not able to perform in the class at desirable level. Apparently, the candidates who are admitted with average percentage are performing better despite of their low percentage obtained in their undergraduate qualifying examinations. As a result, the existing process of taking admission based on high percentage order of merit is virtually depriving the genuine deserving candidates coming from affiliated colleges/institutions for pursuing their higher education. Entrance test would instill sense of competition among the students.
Resolution	The Council deliberated on it and decided to constitute a five-member committee to work out the modalities
AGENDA No. 4	To ratify the syllabi prepared by various Departments of Schools/Colleges
Discussion	The AC noted that the syllabi under CBCS of Science, Arts & Humanity, Commerce & Management were prepared by the respective Departments and approved administratively subject to ratification by the Academic council
Resolution	The Council ratified the action taken by the university authority.
AGENDA No. 5	To approve the mandatory conditions for Ph.D scholars from the current academic session.
Discussion	The AC noted that the university while endorsing the UGC directives and in accordance with the recommendation of the 2 nd Research Council meeting, it was decided to adhere to the mandatory conditions prescribed by UGC for research scholars, wherein it is mentioned that, "That he/she (Research Scholar) should have at least two (02) research publication before submission of PhD thesis".
Resolution	The Council examined the matter and noted that as per UGC norms the mandatory Research Publications in journal are kept at a minimum of two (02) publication, and approved the adherence to mandatory UGC guidelines for Ph.D scholars of the University with prospective effect from the date of approval of the Academic C
AGENDA NO. 06	To ratify the onetime special consideration for rejected candidates to appear for Special Annual Exam.
Discussion	A special consideration was granted to few students for appearing in the special exam for those students who have duration to complete the course and have appeared three times in lower exam (including special exam).
Resolution	The Council ratified the action taken by the University authority.



AGENDA NO. 07	To allow Assistant Professor(s) to register for Ph.D Programme after completion of probation period.
Discussion	The AC noted that as per the Ph.D Ordinance the Assistant Professors who have joined in the University can pursue PhD only after completion of one year of service. However this system needs to be relooked
Resolution	The Council approved that Assistant Professors from YBNU can register for PhD programme after completion of their probationary period. Further, it was decided that the Assistant Professors from constituent colleges should submit NOC clearly stating that aspiring teacher(s) would be granted study leave to carry out his/her research work.
AGENDA NO.08	To approve the Regulations and Course Curriculum for starting one year Diploma in Computerized Accounting Course.
Discussion	The AC noted that the Dean School of Computer Science & IT for developing course curriculum of Diploma in Computerized Accounting ,had submitted the detail regulations and Course Curriculum of the proposed course which was placed to AC.
Resolution	The Academic Council perused and approved the same.
AGENDA No. 09	To consider the mandatory Course Work for research scholars from each disciplines for pursuing PhD in different courses
Discussion	Dean R&D has submitted a representation wherein he has put forwarded the decision of the RC which states that Ph.D scholars from each disciplines must go through course work as prescribed for scholars to pursue PhD as per UGC guidelines
Resolution	The Academic Council noted and approved the same..
AGENDA No. 10	To consider the opening of sports club at YBN University, Ranchi
Discussion	The DSW has proposed to start the sports club for Students aimed at promoting physical fitness, teamwork, and community engagement through regular sports activities and events. The club will serve as a platform for members of all ages and skill levels to participate and improve their skills, and build social connections.
Resolution	It was considered and approved by the Academic Council.
AGENDA No. 11	To consider and approval of the degree awards for Undergraduate (UG) , Postgraduate & Diploma Students
Discussion	The meeting was convened to review and approve the list of students eligible for the award of degrees in the Undergraduate , Postgraduate & Diploma programs. The Registrar presented the consolidated list of candidates who have successfully fulfilled all academic and administrative requirements for their respective programs.



	It was noted that the academic performance and conduct of all listed students had been verified by the respective departments, and all conditions stipulated by the institution's academic regulations had been met.
Resolution	After due consideration and verification, the committee unanimously resolved to approve the award of degrees to the Undergraduate, Postgraduate & Diploma students as presented, up to the date of this meeting, i.e. 17 th November 2022. The approved list will be submitted to the Examination Office for the issuance of official degree certificates.
AGENDA No. 12	To consider and Approval of Course Outcomes (COs), Program Outcomes (POs), and Program Specific Outcomes (PSOs) for all Programs offered by the university.
Discussion	The member secretary had presented the consolidated documents containing the revised and mapped COs, POs, and PSOs submitted by all departments and program coordinators. It was reported that the outcomes have been formulated following the Outcome-Based Education (OBE) framework and in alignment with graduate attributes. Each Dean or department Head briefly summarized the methodology and stakeholder input involved in formulating the outcomes and confirmed that the documents had been internally approved by departmental academic committees.
Resolution	After detailed discussion and review, the committee unanimously resolved to approve the COs, POs, and PSOs for all undergraduate, postgraduate, and diploma programs offered by the University. It was agreed that the approved outcomes will be uploaded to the university website. A copy will be submitted to the IQAC and archived for accreditation and audit purposes. Any future revisions will follow a formal review and re-approval process.
